WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration for receiving permission to participate in the F.O.E. #3781 EAGLES NEST SHOOTING RANGE: I hereby release, waive, discharge and covenant not to sue The Fraternal Order of Eagles #3781, its officers, servants, agents and employees (hereinafter referred to as "**releasees**") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the **releasees**, or otherwise, while participating in the F.O.E. #3781 EAGLES NEST SHOOTING RANGE or upon the premises.
2. I am fully aware of risks and hazards connected with being on the premises and participating in the F.O.E. #3781 EAGLES NEST SHOOTING RANGE, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in the F.O.E. #3781 EAGLES NEST SHOOTING RANGE, and I hereby elect to voluntarily participate in the .O.E. #3781 EAGLES NEST SHOOTING RANGE, to enter upon the above named premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant in the F.O.E. #3781 EAGLES NEST SHOOTING RANGE, whether caused by the negligence of **releasees** or otherwise.
3. I further hereby agree to indemnify and save and hold harmless the **releasees** and each of them, from any loss, liability, damage or costs they may incur due to my participation in the F.O.E. #3781 EAGLES NEST SHOOTING RANGE, whether caused by the negligence of any or all of the **releasees**, or otherwise.
4. It is my express intent that this Release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a Release, Waiver, Discharge and Covenant Not to Sue the above named **releasees**.

In signing this release, I acknowledge and represent that:

- A. I have read the foregoing release, understand it, and sign it voluntarily as my own free act and deed;
- B. No oral representation, statements or inducements, apart from the foregoing written agreement, have been made;
- C. I am at least eighteen (18) years of age and fully competent; or I am under the supervision of a fully competent adult;
- D. I execute this Release for full, adequate and complete consideration fully intending to be bound by same.

GENERAL RANGE SAFETY RULES & REGULATIONS

SAFETY FIRST!!! ANY PERSON SUBJECTING OTHERS TO DANGER WILL BE ASKED TO LEAVE; YOUR SHOOTING PRIVILEGES WILL BE JEOPARDIZED. AGAIN, SAFETY FIRST!!!

Please wear NRA approved proper eyewear, ear protection and also proper clothing.

All Federal Firearm Laws are strictly complied with in the F.O.E. #3781 Eagles Nest Range.

No consuming of alcoholic beverages prior to shooting. Drugs will not be tolerated.

All firearms must be in good working order; Check with a staff member if in doubt.

All firearms brought into range must be unloaded. Load shells only when at firing lane.

All firearms leaving the range must be unloaded and properly stored for transport.

EXCEPTION: Law enforcement officials are authorized to have pre-loaded firearms only.

Always keep firearms pointed in a safe direction.

Always keep your finger off the trigger until ready to shoot.

No unsafe, careless use of guns allowed. No fast draws or dramatic movie-like acts.

Gun safety is in YOUR CONTROL through proper handling; set a good example for all.

When not shooting always have your safety on; treat all guns as "if their loaded".

All persons utilizing the facility are required to read the General Range Safety Rules.

A responsible adult MUST supervise and accompany a minor if minor is shooting.

Cease Firing: Immediately stop shooting when anyone calls "Cease firing."

COLD Range: Shooters must check with others to ensure firearms are unloaded, actions open and firearms laid down on the shooting bench before going down range. No one is permitted to handle firearms or stand at the firing line while there is a cold range.

HOT Range: Shooters must check with others to ensure there is no one down range; when the range is declared "HOT" shooters are permitted to commence firing. Only shooters are permitted on the firing line. Shooters may move safe guns to and from the firing line only when the range is "HOT."

All shooters are responsible for their rounds staying within the confines of this range. Shooters may shoot only from the firing line at the target in line with their position. Firing at ONLY approved target allowed. Firing at any foreign objects not approved.

Respect the Range: Please place your trash into the trash receptacles and your spent shells into the recycling receptacles. Tracer, armor piercing and incendiary ammunition is prohibited.

Respect Yourself: Wear eye and ear protection. Food, beverages and smoking are not allowed on the firing line. You should wash your hands and face after shooting.

FAILURE TO FOLLOW ANY OF THE ABOVE SAFETY RULES MAY RESULT IN EJECTION FROM RANGE. COMPLIANCE TO THESE RULES ARE MANDATORY.

EAGLES NEST HOUSE SHOOTING MATCH RULES

- All shooters **MUST** have a signed **WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT** signed before engaging in any shooting match or practice.
- Judges decisions are final.
- **BE SAFE!!** Please step away from your guns while red lights are activated and while people are down range.
- **40" Barrel Max / Wagner Skeet 9's**
- **Shooting Distance = 56 Feet**
- **Chigger Knock Out Only**
- **Microscope Judging**
- **Two Person Ties (misses) will have a Max of Two Tie Shots before Automatic Split (3=3, 4=4)**
- **Once a card leaves the Judges' table there will be no further review.**
- **Accidental discharge of gun will be your shot**
- **Shooting wrong card = Out that round**
- **All shooters are responsible for their cards each round as well as making sure card is marked by judge.**
